#### Best:

At Basic School when a bunch of us took off for a spontaneous weekend trip to Atlantic City (had to be there!) Got lost on way back, arrived Quantico just in time for morning formation — and what a mess we were in!

#### Worst:

Falling off the O-course cracking left clavicle, dislocating my elbow and having it popped back, and mostly worrying if it would set me back (It didn't – cast came off in time for amphibious exercise). After discharge being told by an Employment Agency in San Francisco; "I see you were with the Marines in Vietnam; you're wasting your time here because we don't hire baby killers".

#### Rank achieved:

No, I didn't stay in the service but did have another year to serve after Vietnam and was promoted to Captain by General Butcher, Commanding General, Marine Corps Base, Camp Lejeune prior to discharge

# Jobs After Vietnam:

Assigned to Camp Lejeune: Served as Base Assistant Operations Officer, Disaster Control Officer (after Chemical, Biological, Nuclear School with "honors at the top of the class" and Nuclear Weapons Orientation), Protocol Officer and secretary to the Commanding General's staff.

#### Other Medals Received:

Not a medal, but did receive a Certificate of Commendation for my Camp Lejeune experience from General Wheeler.
