Minutes

The committee further is recommending that we utilize the Hilton Gardens Inn in Rancho Mirage, that Thursday be devoted to a visit to 29 Palms, Friday to a visit to either the Palm Springs Air Museum or the Palm Springs Aerial Tramway, and Saturday free time with a suggested visit to "The River at Rancho Mirage" and the banquet in the evening.

Considerable discussion ensued in which the following were raised:

- The day spent at 29 Palms may be too long. Chuck Sooter offered that the group be split into two groups; an early return group who do not desire to dine at the base and a later group for those who do.
